Contestant knows and agrees that by his or her signature on this form, he or she completely releases the **NBHA** and its directors, officers, representatives, employees and agents for any liability, including negligence. Contestant voluntarily chooses to participate in **NBHA** sanctioned events and barrel races and freely and willingly consents to same. Contestant further acknowledges that he or she has no absolute property or other right to participate in **NBHA** events. Contestant agrees to follow and be bound by the rules, regulations, and guidelines of the **NBHA** as amended from time to time. Contestant agrees that his or her sole and exclusive remedy for any disputes is appeal to the **NBHA** appeals board pursuant to **NBHA** appeal procedures, and agrees that all decisions of the appeals review group are final and conclusive.
